We take your privacy very seriously. Please read this privacy policy carefully as it contains important information on who we are and how and why we collect, store, use and share your personal data. It also explains your rights in relation to your personal data and how to contact us or supervisory authorities in the event you have a complaint.

We collect, use and are responsible for certain personal data about you. When we do so we are subject to the UK General Data Protection Regulation (UK GDPR).

Personal data we collect about you

We will collect and use the following personal data about you:

- Name of client or contact (business to business data, from local and education authorities, schools and PRUs)
- Name of parents/carers and learner
- · Contact information, including email address and telephone number
- Date of birth of learner
- · Photograph of learner
- · Gender of learner
 - Passport or other ID information of parents and /or learner



- Special categories of information (such as ethnicity, language, country of birth, nationality, information regarding health, special educational needs, allergies and disability).
- Emergency contact details
- Welfare concerns of learner
- Technical Data includes internet protocol (IP) address, your login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access our website.
- Usage Data includes information about how you use our website, product and services
- Cookies Data like many websites, we use "cookies" to enhance your experience and gather information about visitors and visits to our websites.

How your personal data is collected

We collect some of this personal data directly from you (the parent or learner, or client, or client contact) in person, or email. However, we may also collect information from local authorities, school and other alternative education providers regarding parents or children.

How and why we use your personal data

Under data protection law, we can only use your personal data if we have a proper reason, e.g.:

- where the parent has given consent for processing their or their child's data (where required and as per applicable laws)
- to comply with our legal and regulatory obligations;
- · for the performance of a contract; or
- for our legitimate interests or those of a third party.

A legitimate interest is when we have a business reason to use your personal data, so long as this is not overridden by your own rights and interests.



How and why we use your personal data—Special category personal data

Where we process special category personal data, we will also ensure we are permitted to do so under data protection laws, e.g.:

- · we have your explicit consent to process your child's data
- the processing is necessary to protect your (or someone else's) vital interests; or
- the processing is necessary to establish, exercise or defend legal claims.

Who we share your personal data with

We may have to share learner's and their family's data with third parties, including third-party service providers and other bodies such as:

- Education Authorities
- Local Authorities
- Schools
- Tutors who provide education services
- Any third-party providers we may commission or work in collaboration with
- Our cloud service provider

Cookies

Cookies are files with small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyse our service. All Cookies used by and on our website are used in accordance with current UK Cookie Law.

Ask for your copies of your data

You have the right to ask for copies of your personal data we store and use. This is your right of access, also known as making a subject access request or SAR. We'll normally respond at the latest within one calendar month of receiving your request. There may be times where we need longer or we may need to charge a reasonable fee for admin costs. We'll let you know if this is the case.

You don't have to use this form to ask for copies of your data, but it's helpful for us to know what you're looking for so we can respond fully and promptly.
